

# Hudson River – Black River Regulating District

## APPLICATION FOR A COMMERCIAL ACCESS PERMIT AT GREAT SACANDAGA LAKE

TO THE BOARD OF THE HUDSON RIVER-BLACK RIVER REGULATING DISTRICT:

The undersigned hereby make(s) application for a permit granting use of such tract or tracts of State land for access to Great Sacandaga Lake as may be designated by said Board or its authorized representative.

In making this application, I (We) hereby acknowledge that Great Sacandaga Lake is a river-regulating reservoir and that since its surface elevation varies according to the needs of the system of which it is a part, it is not always ideal for recreation. I (We) understand further that recreational use of the reservoir is secondary and subordinate to its regulatory function and must not, therefore, interfere with reservoir operations.

With the above understanding therefore, the undersigned hereby agree(s): to abide by and conform to all rules and regulations of the Board of the Hudson River – Black River Regulating District, and to the rules and regulations of any agencies having any control or jurisdiction over said Lake if the permit herein applied for is granted; and to abide or conform to any other rule or regulation or any other law not now in force which may hereafter be adopted or enacted, which may be applicable to said permit. That the Rules and Regulations of said Board, and all rules, regulations, and laws therein referred to, are hereby constituted as part of this application, the same as if fully set forth herein.

To HOLD HARMLESS the members of the Board of the Hudson River - Black River Regulating District, the District, its officers, and employees against any and all claims, damages, or causes of action for damages arising out of the use of such permit; and further agree(s) to indemnify said Board, the District, its officers, and employees for all such suits, orders, or decrees and judgments entered herein, including the cost of defense of all such claims or suits brought on account of injury to person or property or loss of life sustained by the entry, use, or occupation of District lands under the permit for the duration thereof and during the period subsequent thereto within the statutory period commencing or filing such claims or suits in any competent jurisdiction.

I (We) understand that an access permit is simply written permission to use a segment of State land under Regulating District jurisdiction for access to the Lake; it is not a contract or lease and I (we) am not the owner of the access permit area; the Board reserves the right to determine the width of the access area to be granted; access permits are non-transferable and cannot be sold or otherwise conveyed by their holders; all access permits are issued at the discretion of the Board.

To pay to the district, as part of the consideration for the processing and granting of said new permit, the charges or fees as set forth in the current schedule at the time of the filing of this application; to pay in full such charges or fees as may be levied for the annual renewal of said permit; and to pay such charges or fees in full by check or money order made payable to "Hudson River - Black River Regulating District." And to understand that if the permit herein applied for is granted, that the permit will be in effect on the date of issue and will expire March 15 of the next year.
